HOUSE SET UPS

We are able to set the arena in many different configurations to meet specific event needs and specifications. There is retractable seating around the entire floor that can be used in various ways to accommodate production needs and maximize seating.

GENERAL ADMISSION SEATING

General admission or open floor seating is permitted only with arena management approval. A temporary moat (barricade) will extend around the floor to limit access to the floor.

- Additional power N/S Transfer Hallway at NW Corner of Arena
 - (1) 200amp, 208 volt, 5 wire service
- Power connections are all camlock
- No shore power is available

HOUSE SOUND & VIDEO SYSTEM

- State-of-the-art house sound system providing a full range of high power sound to all seats in the arena bowl.
- There are multiple XLR inputs located in the SW and Center West vomitories on floor level to a patch in the sound booth.
- The House Sound control panel is located in the Arena Sound Booth on concourse level at Section 101.
- The House Ribbon and Corner Boards are controlled from a computer located in the Arena Sound Booth on concourse level at Section 101.
- The House Center Hung is controlled via Tricaster located below Arena Sound Booth
- SDI tie ins are in the Center West and NE Vomitories.
- **Any use of House Sound or Video must be advanced with Event Manager.


RIGGING AND STAGEHAND SERVICES

RIGGING

- East/West beams on 30' centers run the width of the arena
- One center North/South beam runs the length of the arena
 - Please note: this beam cannot be used for rigging
- All rigging steel is 87' above the arena floor
- Each beam can hold a maximum weight of 20,000 lbs. with a per point maximum of 5,000 lbs.

STAGEHANDS

OVG360, operator and manager of Donald L. Tucker Civic Center, is in contract with IATSE (International Alliance of Theatrical Stage Employees). IATSE is a union labor workforce. All labor needs will go through your Event Manager and the facility for all events.



PERMITS & SPECIAL APPLICATIONS

SPECIAL PERMITS NEEDED

Special permits needed for any pyro displays must be submitted thirty (30) days prior to the event.

FIRE LANES AND FIRE PROTECTION EQUIPMENT

- Booth displays, signs, etc., shall not block or obstruct any fire hose, fire extinguishers, fire alarm pull stations or any other fire protection appliance inside the Arena. A certified fire watch representative must be on duty during an event.
- No fire protection equipment outside of the building shall be obstructed or blocked in any way. This includes sprinkler system valves, standpipes, hydrants, fire escape/ smoke evacuation roll up doors, fire command rooms, or any item, location or device designated for protection use.
- No vehicles shall be parked in the fire lanes outside of the Arena.

INSURANCE & INDEMNIFICATION

INSURANCE

The Donald L. Tucker Civic Center requires all clients/licensees, at their own cost and expense, to obtain their own commercial general liability insurance in the name of the Licensee. Such insurance shall be written with a limit of at least One Million Dollars (\$1,000,000) for bodily injury, property damage and personal injury. Licensee shall cause such insurance to be deemed primary to and not contributory with any insurance coverage or self-insured program of the Indemnitees. Insurance effected or produced by Licensee hereunder will not reduce or limit Licensee's contractual obligation to indemnify and defend the Indemnitees hereunder.

Such insurance shall name Donald L. Tucker Civic Center, Global Spectrum, L.P., and Florida State University and each of their respective parent, affiliate and subsidiary companies, officials, officers, directors, employees, and agents as additional insureds.

Licensee shall also maintain, at its own cost and expense, workers' compensation insurance in respect of all employees, players, performers and any borrowed, leased, or other person to whom such compensation may be payable by Licensee. Licensee shall also maintain, at its own cost and expense, with insurance companies currently rated A VIII or better by Best's Key Rating Guide, commercial automobile liability insurance, including coverage for the operation of owned, leased, hired and non-owned vehicles, in the minimum amount of Five Hundred Thousand (\$500,000) per accident, combined single limit for personal injury and property damage.

Licensee, at least thirty (30) days prior to the commencement of the Term, shall provide to the venue evidence of the insurance required. The policies shall also provide, and the certificate shall so note, that the coverages may not be canceled or that a major change in coverage may not be implemented without at least thirty (30) days prior written notice given to the venue. All insurance policies shall be issued by insurance companies rated no less than A VIII in the most recent "Bests" insurance guide, and licensed in the state of Florida.

INDEMNIFICATION

Licensee agrees to indemnify, defend, save, and hold harmless the venue, Donald L. Tucker Civic Center, The Florida State University Board of Trustees and Global Spectrum, L.P. and any other present or future lender providing financing to Florida State University in connection with the construction or operation of the Facility, and their respective successors and assigns each of their respective partners, agents, officers, directors, employees and representatives from and against any and all claims, suits, losses, injuries, damages, liabilities and expenses.

SECURITY

SECURITY STAFF

Event Security is staffed by Sentry Event Services (Sentry). The Tucker Center will schedule staff based on event needs. Sentry is responsible for Entry, BOH, FOH, and stage side security during the event.

Guest Services is staffed in-house by the Tucker Center.

SECURITY CHECK

All guests entering the venue are required to have bags searched and proceed through walk-through metal detectors.

POLICE DEPARTMENT STAFFING

The Florida State University Police Department oversees all law enforcement duties at the Tucker Center.

ON-SITE MEDICAL TEAM

The Tucker Center will provide in-house EMT service for all guests in attendance. Ambulance Service can be arranged through advance with Event Manager.

PATRON REGULATIONS

The following items cannot be brought into the arena by patrons:

- Professional Cameras
- Video Recorders
- Tripods
- Weapons of any kind
- Selfie Sticks
- Laser Pointers
- Food, Drinks & Alcohol
 - Empty plastic cups or bottles will be permitted
- Air Horns/Noise Makers
- Laptops
- Offensive Banners/Posters
- Controlled Substances
- Coolers
- Wrapped Gifts
- Personal Transportation Devices
- Costume Masks
- Beach Balls or other airborne items
- Balloons
- Other items identified by the security team



ARENA RULES AND REGULATIONS

CAMERA POLICY

Small non-professional cameras are allowed in the building for most events. Professional cameras can be classified as any camera with a detachable lens. Policy is subject to change per tour request.

RE-ENTRY POLICY

The Donald L. Tucker Civic Center has a no re-entry policy. If you enter the facility and then leave, you must have an unused ticket to re-enter the arena. For emergencies and special exceptions, please visit the Guest Services desk located behind Section 101 on the main concourse.

LOST AND FOUND

During an arena event, Lost and Found is located at the Guest Services desk located on the concourse outside of Section 101. After an event, guests should contact the Tucker Center Box Office at (850) 645-0747 or the FSU Police Department's Lost and Found at (850) 644-5960.

ALCOHOL

To purchase alcohol you must be 21 years of age or older and present a valid state-issued Driver's License. Guests are not permitted to bring in any outside alcoholic beverages, nor are they permitted to leave the building with alcohol purchased inside the Donald L. Tucker Civic Center.

SMOKING

Smoking is permitted in designated smoking areas.

MERCHANDISE/NOVELTIES

The Donald L. Tucker Civic Center partners with OuiVend for all merchandise sales. Contact your show Event Manager for more information.

ARENA RULES AND REGULATIONS

RESELLING OF TICKETS (SCALPING)

Florida Law prohibits the reselling of tickets on Tucker Center Property.

SELLING OF ILLEGAL MERCHANDISE (BOOTLEGGING)

Selling of nonauthorized merchandise (merchandise not sold under the approval of the Donald L. Tucker Civic Center Management) is prohibited on Tucker Center property.

FOOD AND BEVERAGE/CATERING

OVG Hospitality is the sole provider of food and beverage operations at the Donald L. Tucker Civic Center.



PARKING

There are approximately 1,400 parking spaces within walking distance to the Donald L. Tucker Civic Center that can be utilized for event parking as needed. This includes one (1) parking garage and one (1) surface lot. Parking charges vary per event.

Show parking is available in the lower back lot for all show busses, trucks, and vans.



FOR PATRONS WITH DISABILITIES

ADA parking is located in the Tucker Center's North and East drives on a space available basis.

The arena is equipped with an in-house listening device system for the hearing impaired.
